The principal business of said Club is conducting martial arts classes. The student and/or member agrees to abide by all rules set forth by the Club and fully understands that failure to do so will result in disciplinary action, up to and including expulsion, for which there will be no refund.

The student and/or member shall be financially responsible for all dues in accordance to the following payment plan set forth by the Club. Monthly fee is \$30.00/first student; \$5.00 reduction/month for each additional student thereafter. An initial payment of three (3) months membership into the Club will entitle student to receive a free uniform & white belt. The student's first payment is due upon formal membership into the Club and each subsequent payment will be due on or before the 15th of each subsequent month. Except as provided by this agreement, no student shall be entitled to a refund, nor shall any student or member be relieved of his/her obligations to pay the total payment for any accumulated arrearage, unless otherwise waived by the Instructor.

The student or member agrees to assume all risk of personal injury (including death) while attending and/or participating in study and/or practice of any Martial Arts taught at the Club, and acting for himself or herself, his or her heirs, personal representatives, and assigns does hereby release the Club, Owners of any property used, and it's representatives in any capacity personal or otherwise, from all liability, including claims and suits at law or in equity for any injury, fatal or otherwise, which may result directly or indirectly from traveling to, participating in or returning from said Club, and outside of said Club.

I, the undersigned, understand that any pictures taken of the student or member participating in said Club activities may be used for publicity without compensation. By signing this agreement, the student or member avers that they are an adult resident of the United States of America and that they fully understand all of the terms and conditions referenced above within this agreement.
